Right Honourable Mr. Cholendra Shumsher J B Rana, Chief Justice of Nepal, paid an official visit to Moscow at the invitation of His Excellency Mr. Vyacheslav Lebedev, Chairman of the Supreme Court of the Russian Federation on May 19-22, 2019. The Rt. Hon. Chief Justice of Nepal was accompanied by his spouse Mrs. Reji Chettri Rana, Mr. Nripa Dhwoj Niroula, Chief Registrar of the Supreme Court of Nepal and Mrs. Samjhana Simkhada, Section Officer of the Supreme Court of Nepal.

Right Honourable Mr. Cholendra Shumsher J B Rana had a meeting with His Excellency Vyacheslav M. Lebedev, Chairman of the Supreme Court of the Russian Federation at the latter's office on May 20, 2019. Chief Registrar Mr. Nripa Dhwoj Niroula, Ambassador of Nepal H.E. Mr. Rishi Ram Ghimire, Section Officer Mrs. Samjhana Simkhada and Second Secretary Mr. Khimanand Bhusal were also present in the meeting.

Matters of mutual interest including the cooperation between the Institutions of Judiciary of both Nepal and Russian Federation were featured during the meeting. Right Honourable Chief Justice of Nepal mentioned that the New Constitution of Nepal was promulgated four years ago and highlighted the main features of it. The Rt. Hon. Chief Justice told that the new constitution has been implementing successfully. Both Chief Justice and the Chairman agreed that the continuity of the exchange of visits and interactions will help strengthen the relations between the judiciary and enrich understanding of the judicial system of both countries. On the occasion, Rt. Hon'ble Chief Justice of Nepal extended an invitation to His Excellency Vyacheslav M. Lebedev, Chairman of the Supreme Court of the Russian Federation to visit Nepal at his convenient time. H.E. the Chairman accepted the invitation.

The delegation of Nepal also visited the Judicial Department of the Supreme Court of the Russian Federation on 20 May and met with Director General of the Judicial Department Mr. Alexander Gusev. The Nepalese delegation was briefed on the functions of Judicial Department. The delegation of Nepal had also a meeting with the court President Mr. Nikolay Novikov, Commercial Court of the City of Moscow on 21 May 2019. Mr. Novikov briefed the delegation about the Commercial Court of the City of Moscow.

Before coming to Moscow Rt. Hon'ble Chief Justice of Nepal attended the IX International Legal Forum in St. Petersburg organized by the Constitutional Court of the Russian Federation from 14 May to 18 May 2019. The delegation will be leaving this evening for Kathmandu.
