Urgent Notice on the Travel requirement to Nepal

As per the decision of the Government of Nepal dated 21 June 2021, all travellers, foreign and Nepali, are required to follow the following health and quarantine guidelines:

1. All travellers are mandatorily required to present a negative PCR test with a photo identification or barcode, obtained within maximum of 72 hours before the time of departure. The PCR reports of Russian Federation and other accredited countries don't have photos and have barcode/QR code which has been already notified to the Nepalese authorities.
2. Must present the printed barcode generated after filling the Abroad Returnee Management System form available in the website of the Covid Crisis Management Centre i.e., <https://ccmc.gov.np/> (the website can be accessed using a VPN). For those travellers unable to obtain the barcode and fill the form due to unavoidable circumstances shall be made to fill up the form by concerned Airline services in coordination with the Ministry of Culture, Tourism and Civil Aviation at the Tribhuvan International airport prior to health examination.
3. Travellers travelling to Nepal after fulfilling above-mentioned conditions shall have to stay in the Hotel Quarantine in the hotels they have booked in prior, which are enlisted as the hotels for quarantine by the Department of Tourism, at their own expense for 7 days provided that the traveler exhibit no symptom of COVID-19 during the health screening at the airport. Upon the completion of 7 days of home quarantine, the travellers have to take PCR test according to the availability at their own expense. They can leave hotel quarantine on condition of shifting to home quarantine for 4 more days after getting negative PCR report on 7th day.
4. Travellers with symptoms of COVID-19 shall be sent to isolation center or designated COVID hospital.
5. Travellers with the certificate of full vaccination against COVID-19 with a negative PCR report will be allowed to leave for their respective destinations on the condition of self-quarantine of 10 days.
6. Travellers traveling to Nepal for participation in cremation or the last rites of their deceased family members shall be allowed to leave for their destinations upon a negative Antigen test at the airport. He/She shall have to take a mandatory PCR test on the 11th day.

7. In the case of patients with chronic health conditions, physical disability, differently able and accompanying attendant of the patient, permission will be granted upon the submission of supportive documents and recommendation of the local level to go home/destination on the condition of staying in 10-day home quarantine after a negative antigen test at airport. Such person shall take PCR test mandatorily on 11th day.
8. In case of people above 70 years of age, senior citizens, infants and parents of infants, permission will be granted after negative antigen test to leave for home/destination on the condition of staying in 10-day home quarantine. They should take a mandatory PCR test on 11th day. The concerned local level will monitor it.

(Travellers travelling to Nepal pursuant to clause 7 and 8 in the notice and having a positive antigen test at the airport will be sent to isolation center or designated hospital.)

9. Officials of Diplomatic Missions, International Organizations, staff and their family members can go to home/destination, upon recommendation of the concerned missions through the Ministry of Foreign Affairs, on the condition of staying in 10 day home quarantine.
